## <u>Couse plan on "Cutting-edge Digital Skills for Professional Care Givers of Persons</u> with Disabilities and <u>Mental Health Problems</u>"

The course will especially benefit professional care givers interested in exploring digital and technical solutions to upgrade the **assistance**, **social interaction and overall wellbeing** of people with disabilities and mental health problems. This course plan is at European Qualification Framework (EQF) Level 5, equivalent to intermediate higher education qualifications. It will accredit the participating professionals with an ISO 17024 certification after successful completion of the course.

The four focus areas are:

- New Technologies
- Self-Advocacy, Technology Acceptance and Ethical Issues
- Social Networks Development
- Therapeutic Role Playing

#### **Certification Scheme for the course contents**

The Certification Scheme is intended for the **certification of training materials and the curriculum** that will be developed within the DDSkills Project. It contains principles and requirements for the assessment and certification of the training for caregivers of persons with disabilities and mental health problems into new digital skills and technologies that can prove beneficial for the users. All training materials and curriculum that will be developed within the DDSkills project can be certified as per the criteria of this scheme.

#### **Certification Scheme for trainees**

The Certification Scheme is addressed to professional Care Givers of persons with Disabilities and mental health problems (occupational therapists, psychologists, social workers, special education teachers, nurses, gerontologists, rehabilitation experts). This Certification Scheme intends to provide a certification to Care Givers that want to grant an additional certified qualificationas as Certified Supported Living Caregiver at EQF Level 5. Every caregiver that fulfills the criteria as described in the current scheme, can apply for the certification and after passing the assessment can get certified.
